

General Terms and Conditions

The present General Terms and Conditions (hereinafter referred to as “Contract” or “GTC”) set out the rules for using by the user (hereinafter, the “Visiting User” or “Uploading User” or, collectively, “User”) of the <http://mysextinglive.com> online community site and repository (hereinafter, the “Website” or “Community Site” or “Service”) operated by Myname Social Media Kft. (address: 1054 Budapest, Szabadság tér 7. Cititorony, I. emelet; Cg. 01-09-285687; tax number: 25723007-2-41; hereinafter referred to as “Myname Kft. “ or “Operator”).

Definitions:

ECSA: Act CVIII of 2001 on electronic commerce and certain matters concerning information society services

Recipient of the service or, in this Contract, User: for the purposes of this Contract, any natural or legal person or entity lacking the legal status of a legal person who uses an information society service;

Visiting User: who is visiting the Website while using the information society service, but does not upload any content (images, videos, live broadcast) to it;

Uploading User: who also uploads contents to the Website while using information society service;

Information Society Service: services provided electronically and normally for financial consideration at a distance and at the individual request of the recipient of the services;

Services provided from the territory of Hungary: any information society service provided by a service provider who is in fact engaged in activities relating to the information society service in question at its registered office, permanent establishment or private residence located in the territory of Hungary;

Application Provider or, in this Contract, Operator: natural or legal person or other entity lacking legal personality who/which provides access to any software or hardware or software applications or related services through a specific software or Web interface by using an electronic communications network to multiple users in a time-limited or unlimited way and for a monthly or used-based consideration or free of charge;

Contents of the Service

Mysextinglive.com is an interactive community website for adults, featuring erotic content. The Operator is operating the Website as an intermediary service provider according to the provisions of Act CVIII of 2001 on electronic commerce and certain matters concerning information society services (hereinafter, the “ECSA”) by providing an online community space to the Users of the site. In addition to providing the community space, Myname Kft. does not upload any content to the Site and the contents thereof are provided by the Users to one another. The community site is primarily intended for users to share certain moments with each other.

The adult entertainment available on the Website are provided by men and women to themselves and the members of the community site by uploading pictures and videos about certain periods of their everyday life, commenting on them and sending pictures and videos to other users of the Website, with whom they can also engage in private correspondence on the community site.

Some users provide live web camera presentation in front of their cameras to users anywhere in the world.

Users can use the Site remotely and none of them is an employee, (sub)contractor or other agent of the Operator.

Acceptance and term of the Contract

By making the explicit declaration during login and using the Website, an online contract is made between the user and Myname Kft. pursuant to the ECSA. The online contract enters into force on the date of acceptance by the user.

The Operator makes available these contractual terms and conditions concerning information society services in a way which enables the Users to store and reproduce them. The Contract can be found in Pdf format on the login interface of the Community Site.

Prior to using the Service, Users must first accept the Contract. The Service is not available unless the Contract is accepted.

The terms and conditions of this Contract are accepted by the Parties by using, visiting, logging in and voluntarily registering on the Website. The acceptance of the Contract creates a legally binding agreement between the User and Myname Kft. for the use of the Website. By accepting the Contract, the User consents to using the Website in accordance with the terms and conditions laid down in the Contract.

Prior to acceptance, Users can print or save a copy of the Contract, and accept the Contract after reviewing the details thereof.

Users can accept the Contract as follows:

(a) By clicking in witness of the acceptance of the Contract, which the Operator makes available to its Users on the login interface of the Website by putting a tick in the box before the “I HAVE UNDERSTOOD AND AGREE TO THE GENERAL TERMS AND CONDITIONS AND THE DATA PROTECTION POLICY” line;

(b) Through the use of the Website by the User. Users acknowledge and agree that the Operator will consider use of the Website in a way that the User has accepted the Contract.

A User may not use the Service or accept the Contract if:

(a) He/she has not yet turned the age of 18. Accessing the Website by minors is strictly prohibited.

(b) The law of the country where the User’s home address or the User’s place of use prohibit the use of the Website.

(c) Viewing the sexually explicit adult content can in any way harm the User and his/her belief. It is not recommended to visit the Website by individuals sensitive to adult content, and they will exclusively bear the responsibility in the case of a visit.

User declaration

The User declares that he/she has turned the age of 18.

The User declares that he/she is staying in the country marked during the login and accepts full any exclusive responsibility for any false declarations relating to the place of residence.

The User declares to use the Service at his/her own responsibility.

The User declares to agree with these terms and conditions and accept them as fully valid with respect to him/her.

The User declares that he/she is viewing the sexual content on the Community Site for personal use and out of his/her own will. He/she shall not under any circumstances forward or show to any persons under the age of 18 or children any of the contents he/she has viewed.

The User declares to have understood and accepted that the Website may contains sexual content and that such content may not in any form or manner be construed as being offensive, hurtful or threatening.

The User declares that reading, visiting or downloading the content on the Community Site do not violate the laws, regulations or rules of the country or settlement where his residence is located.

The User declares to have understood that he/she is responsible for content that he/she displayed on the Website.

The User declares to use Service for personal use only.

The User declares to use only his/her own payment instruments for buying credits and paying with credits on the Community Site.

The User declares and has understood that he/she forfeits and waives the right of cancelling the transaction after the credit purchase or paying by credits.

The User declares to accept full responsibility for any false disclosures and any possible legal consequences resulting therefrom.

The User declares not to place any advertisement, promotion or link without the consent of the Operator.

The User declares that he/she will use the Community Site according to the relevant laws and regulations.

The User declares not to use any automated device, application or programme (robot, spider, script, etc.) nor any manual process while visiting the Website with the intention to monitor or record any of the content of the Website.

The User declares not to use any tool, programme or process to bypass, modify, disrupt or potentially disable the Community Site or any servers and networks connected thereto.

The User declares not to disproportionately and unnecessarily load the Operator's infrastructure.

The User declares to use the Community Site only for purposes, in a way and with the content approved by the Contract or the law.

The User declares and accepts that the user is responsible for declaring and paying any taxes arising in the location of his/her place of stay or place of residence or any other location relevant from the taxation point of view. He/she shall comply with all applicable tax laws, including the obligation to make declarations and payments of the taxes arising in relation to the transactions.

The User declares not to reproduce, copy, sell, distribute or market any content of the Community Site for any purpose.

The User declares to be exclusively responsible for any violation of any of his/her obligations laid down in this Contract, further, that the Operator is not responsible in any manner towards

the User or any third party. In addition, the User is liable for the consequences of any breach of the Contract.

The User declares and agrees to that Myname Kft. uses his/her data as described in the Data Protection Policy.

The User declares to consent to the Operator inspecting, monitoring and recording any content and drawing up a protocol of all activities on the Website in order to filter out possible violations. The User agrees to that any recorded contents or original works created by using the Services of the Community Site, together with all the rights related thereto, including, without limitation, any copyrights, are the Operator's exclusive property.

Prohibited contents

Publishing any forbidden content on the Community Site is prohibited and will entail criminal liability. Such content will be immediately deleted. Users must report to the Operator any illegal content they detect without delay through the electronic contacts provided in the present GTC. The Operator is constantly monitoring the Community Site to prevent the uploading of any illegal content, however, the Operator is not responsible for the acts or information communicated by the Users and the control it is exercising is not mandatory.

The Operator will immediately and permanently suspend and delete the User account of any User who uploads contents to the Website (written, visual, video or other content), which contains any abuse of or violence against any persons under the age of 18, incest, violence, necrophilia, humiliation of any other User, threats of suicide or life hazard, barbarity, bestiality or encouraged any unlawful activities. In such cases of cancellation, the Operator is not responsible for any possible damage and will not refund any amount or credit compensation.

Other contents that are not allowed:

paedophilia, racism, exclusion, hatred, threats against any group or person, harassment of another person or any support thereof, pornography, deliberately disclosing false information, intentional misrepresentation, promotion of any illegal activity, rude or obscene or abusive or insulting or defamatory behaviour; promotion without permission of any proprietary illegal/pirated copies, including pirated computer programmes, music or links pointing at them, password-protected websites, hidden pages or images, or webpages containing commercial pornographic contents. It is not permitted, either, to advertise, recommend or promote any third party products or services or carry out commercial activities, including the following marketing activities: competition, barter, draw, organization of pyramid game.

It is expressly prohibited for the Users to offer services outside the framework of the Community Site or solicit their use, whether for consideration or free of charge, including, but not limited to, sexual services or communicating in other systems.

Making any personal contact with the Users, providing any escort service, prostitution, requesting or offering money or encouraging the User to spend in any unfair way are all forbidden.

In the case of the posting of any unauthorized content (written, visual, video or other content) on the Website, the Operator may suspend or cancel the User's account without prior notice. The User disclaims any liability for any damages and will not refund any amount or credit compensation due to the cancellation.

Protection of minors

Only persons aged above 18 are entitled to use the Website. One can enter the Website only after making a personal statement regarding the age, namely, that the declarant has turned 18.

In the absence of such a declaration, the Website cannot be used, however, the Operator is in no position to verify the veracity of the statement.

The Operator is hiding in the programme description of the Site a warning including information on the potential jeopardy of minors which refers to the category of the content and can be recognised by the filtering software under Section 149/A(1) of Act C of 2003 on electronic communications (hereinafter referred to as the “ECA”), so as to prevent minors easily access the Website.

Myname Kft. condemns any act committed against minors. In the case of the slightest suspicion, the Operator will immediately and permanently suspend access by the affected users, and notify the competent authorities.

By accepting this Contract, Uploading Users declare that they have turned 18 at the time the photo, video, live broadcast or other visual media is made and appears on the Website and, in order to prove their date of birth, upload a copy of their identification documents on the registration interface of the Community Site, which clearly shows the User’s name and date of birth. The Operator is not responsible for the authenticity of the uploaded document and the operator of the Site cannot control the veracity thereof.

The Operator reserves the right to immediately and permanently suspend and cancel the User Account of any User who is using a name that refers to minority or offends others or creates an appearance of minority or if there is the slightest suspicion of falsification of the document provided to verify the date of birth. In such cases, Myname Kft. is not responsible for any possible damage arising from the cancellation and will not refund any amount or credit compensation.

Becoming a member. Registration

The registry database distinguishes between two types of users: Visiting Users and Uploading Users. Visiting Users provide their user name of their choice, password and e-mail address, as well as their date of birth during the registration process. In addition to this data, Uploading Users also register their first and last name, country of stay, bank account number (SWIFT code) and a consent to that the user in question fulfils his/her tax liability in his/her country of stay and, in order to prove his/her date of birth, the photo of an identification documents, which clearly shows the User’s name and date of birth. In order to make a security data check, Myname Kft. may send a verification e-mail for identification. This data is essential for verifying identity, communication and billing, as well as to verify the fact that the User is able to prove beyond reasonable doubt that over he/she has turned the age of 18 at the time of registration.

The Operator is not responsible for any unauthorized access to the Website or any legal consequences arising from such access or any unauthorized use of the materials on the Website.

During registration, Users are required to provide real data that can be associated with them.

If the Operator becomes aware that the dataset provided by the User contains unreal data (as well), it may restrict the User's access, whether in part or in whole, or exclude the User from using the Website.

The username provided during registration must not contain contact information (telephone number, URL, IM ID, etc.) or any lewd or obscene phrase either in Hungarian or a foreign language. If the User provides a name that is considered irregular as described above, the Operator may restrict the User's access without prior notice.

Usernames can include the following characters: uppercase and lowercase letters without accents and numbers. Only and exclusively individuals may be Users of the Website. After login, the Website is divided into sections that provide free and paid services.

Upon login, Users have the option to use the reduced content of the Community Site without registration by clicking the "Just browsing" button.

The personal data provided by the User are recorded in the "My data" menu in the user account. Users must enter any change in their data in their personal menu and will be responsible for any liability arising from their failure to act accordingly. In case of a change of personal data, the Operator requires the User to enter his/her password again.

Promotional agency contracts

Myname Kft. may enter into custom promotional contracts with Model Agencies. Promotion contracts may influence the credit redemption percentages of Uploading Users contracted with the given Model Agency. Uploading Users declare to notify the Operator by providing the agency code during their registration on the Community Site if they are contracted with a Model Agency. If an Uploading User fails to meet this obligation, Myname Kft. does not assume any liability or obligation for any arising damages, make any credit entry retroactively or refund any amount. Uploading Users declare that the Visiting User, Uploading User and promotional credits are determined in all cases on the the basis of the internal accounting of the Website's Operator.

Data protection

It is the principle of Myname Kft. that its data processing related to the services of the Website complies with the requirements set out in the Data Protection Policy and the legislation in force. In the course of data processing, personal data are processed only based on the consent of the data subject or as required by law. In order to protect the personal data of the Users of the Community Site, the Operator considers respect of its clients' right to informational self-determination a priority. Myname Kft. keeps personal data confidential and takes all safety, technical and organizational measures that guarantee the security of the data. Myname Kft. does not sell, rent or share the data collected on the Website without the prior consent of the person concerned. Myname Kft. is using the data collected by it only for the specific purpose and observing the Users' interests.

Data kept by the Operator about the User may be used for resolving any arising matters or disputes. Users may review and change the information provided at any time. If the User changes his/her data, the Operator may store his/her previous data during the period of user eligibility pursuant to the Data Protection Policy.

Pursuant to the Hungarian data protection regulations, Myname Kft. may on a case by case basis collaborate with local, national or international authorities and Myname Kft. is required to disclose the necessary data and information stored about the User at the legitimate request of such authorities.

Pursuant to Section 3/A of the ECSA, the Operator may process the natural identification data and home address of the recipients as required for contracts for information society services, for defining their contents, for subsequent amendments and for monitoring performance of these contracts, for invoicing the relevant fees, and for enforcing the claims arising out of or in connection with such contracts. Further, it may process natural identification data and home address for the purposes of invoicing for the fees payable under the contracts for the provision of information society services to the extent related to the use of information society services, and information relating to the date, the duration and the place of using the service.

Security

During its operation, the Operator takes serious security measures to protect data from unauthorized access, modification, disclosure or deletion. Myname Kft.'s IT systems, particularly its server protects the data stored therein against computer viruses, cyber intrusions and attacks causing refusal of services. Myname Kft. regularly monitors the system and the system monitor allows checking the effectiveness of the security measures adopted as well.

The employees of Myname Kft. are under a duty of confidentiality in respect of the Users' personal data. In case of any violation of these obligation, they can expect disciplinary measures, including the termination of employment or, in serious cases, criminal consequences.

It is strictly forbidden for the Users of the Website to record the personal images, videos and other shared contents of the Users in any manner outside the Website. To this end, a watermark is attached to each image uploaded to the Website.

It is prohibited for the Users to disclose or request personal data or information, including e-mail addresses, messaging IDs, postal address, home address, bank account number or mobile or landline telephone numbers.

The User is responsible for keeping confidential the login data associated with his/her User account and must take all reasonable precautions to ensure that these data are not obtained by any unauthorised person.

Users must immediately notify the Operator at any of the contacts in the "Contact Us" section if they become aware of loss, theft, misappropriation or unauthorized use of their Login data. Users are obliged to inform the Operator of any other breach of the security of the Community Site of which they become aware.

In addition to excluding its liability, the Operator may, by taking any unilateral measure without further notice, suspend use of the User's Login data or User account if it suspects that their security has been compromised or they have been used without authorisation or fraudulently.

Cookie, spam, newsletter

For the sake of customized service, the service provider places a small data packet called cookie on the User's computer. Myname Kft. provides comprehensible and detailed information to the Users about the use cookies by means of the following information placed on the Website.

“Cookies are small text files that are placed by the visited websites in your computer's browser. Cookies are not connected to the user's system and do not damage the user's files.

Cookies may be “permanent” or “temporary” cookies. Permanent cookies are stored by your browser until a specified date, unless they are deleted earlier by the user. Temporary cookies are not stored by the browser, but automatically deleted when the browser window is closed.

Our website (MySextingLive.com) also use cookies. We are not collecting data that allow personal identification, unless provided by the user voluntarily. The data is used for improving our Website and analysing our popularity.

If the user disagrees with placing the cookie (cookies) he/she can do so by making the necessary settings in his/her browser (ban, withdrawal). Disabling cookies may restrict or prevent the use of certain services.

Users can delete the cookie from their computer or set their browser to disable the use of cookies. In addition, Google allows the users to disable the cookies placed by Google on the site for disabling cookies placed by Google (http://www.google.hu/privacy_ads.html). Disabling the use of or deleting cookies can make the use of websites uncomfortable for the users.

Myname Kft. will do everything to protect its subscribers from the harmful effects of spams.

Myname Kft. will not send unsolicited messages and does not tolerate spams. It distancing itself from all activities related spam.

Myname Kft. does not send newsletters to the registered email address. News concerning the Community Site are published on the Website.

Fees and invoicing

The website contains free and paid content services. Paid services are available for registered Users. On the Community Site, the price of the paid services are indicated in credits. Before selecting the paid services on the Website, the User must make sure of the the nature of the related content, the credit price chart and the payment methods that can be used on the Website.

Free of charge services: all services on the Community Site other than the paid services, including registration.

Paid services: sending private messages (except for the response message of the Uploading User), following users, requesting images or videos, live stream, highlighting profiles.

Users can purchase credit packages for uploading their balance or pay for the services by using promotional credits. Purchased and promotional credits can be combined.

The fee to be paid for the credit packages and the value of the credits when redeeming credits depend on the geographical location where the user account is created, the bank card used and the terms and conditions relating to account management and currency conversion of the user's account managing bank. Myname Kft. does not exchange foreign currency as part of the Service. Myname Kft. is entitled to the rounding of prices. All users must consult their bank regarding the banking charges, which are borne by the users.

The Operator may modify its currently displayed credit tariff items or expand the range of services subject to fee payment, of which it must inform the users.

In the case of buying using Paypal, the User pays for the purchase on his/her Paypal site or using his/her Paypal account or, if paying with a bank card, the user is required needs to enter his/her the bank card information. The bank card data of Users using their bank card for buying credits are not saved or stored under any circumstances. Credits will be credited to the User when the bank has confirmed the transaction. Only bank card types listed by the accepting bank card provider are accepted.

In the case of any fraudulent transaction, the Operator reserves the right to use all available information during the various legal proceedings, including, in particular, browser history, IP addresses and e-mail addresses, as well as any other traceable online action. The Operator is to notify and provide information to the authorities during such law enforcement procedures. Users are responsible for any investigation and collection expenses related to any fraudulent transaction.

The Operators is operating the Website as an intermediary service provider. Accordingly, the credits of the paid services are credited to the Uploading User uploading the contents of the paid service. Uploading Users are entitled to redeem their credit balance. Uploading Users accept than only credits of or exceeding 100 EUR may be redeemed. The system of the Website issues a redemption certificate about the credits redeemed, which the Uploading Users can print and download at any time from the "Credit certificates" menu item of their user accounts.

In case pictures or videos are requested, the credit payable for the service will only be credited to the Uploading User when content from the Uploading User arrives in the user account of the Visiting User. Uploading Users are allowed 5 days for uploading the requested content. After the 5th day without uploading, the system declares the request unsuccessful and the credit will not be credited to the Uploading User.

Only Uploading Users may redeem credits. Visiting Users waiver their right of withdrawal/cancellation. Accordingly no refund or cancellation of any kind will be accepted if the Visiting User has paid for the purchased credit package or started to pay for the relevant service.

The Operator charges a referral fee for operating the community site, so Uploading Users can redeem their credits at a reduced value.

Paying for a service by using promotion credits will not be credited to the balance of Uploading Users. If the User pays for the services by using promotional credits only in part, only the purchased credits will be credited to the Uploading User who uploads the contents of the paid service.

Visiting User, Uploading User and promotional credits are determined in all cases on the the basis of the internal accounting of the Website's Operator.

Myname Kft. issues an electronic invoice after each credit purchase and sends it to the e-mail address provided by the User during registration. The digitally signed invoices are suitable for tax identification. Myname Kft. does not produce any printed invoice in paper form. Electronic invoices are suitable for tax identification only in electronic format and should be presented to the tax authority only electronically. Therefore, Users, acting as taxpayers, should keep the downloaded and digitally signed invoices in electronic format until the end of the limitation period. User irrevocably consent to issuing electronic invoices as described in this clause.

Copyright

It is prohibited to broadcast, distribute, disseminate or reproduce in any manner any content information, logo or brand name that is copyrighted or owned by any another person without the written permission of the legitimate owner. All contents, live streams, images, graphics, applications and texts on the Website (the list is non-exhaustive) are protected by copyright, so they may be viewed solely for personal use.

Uploading to or accessing the Community Site or the sharing or publishing information or content thereon automatically implies that the publisher has the necessary copyrights, for which he/she grants an irrevocable and non-exclusive worldwide licence to the Operator without any financial claims, including the right to use, copy, display, list and distribute.

In case any content infringing any copyright or trademark is detected, so that the information appearing on the Community Site infringes the rights or trademark of the User to his/her copyrighted work, performance, sound recording, programme, audiovisual work or database, the ECSA entitles any User to invite the Operator by means of a private document with full probative force or a public document to remove the information infringing his/her right.

Liability

Myname Kft. is not responsible for the actions of the users or the information disclosed, which is offensive, incorrect, inaccurate or false.

Myname Kft. may not be held responsible for any materials or information uploaded and published by the registered users.

Uploading or publishing materials, information or contents to the official websites of Myname Kft. automatically implies that the user has the necessary copyrights, for which he/she grants an irrevocable and non-exclusive worldwide licence to Myname Kft. without any financial claims, including the right to use, copy, display, list and distribute.

The Website may be used only in accordance with the applicable laws and regulations at all times.

Myname Kft. is not responsible for any unauthorized access to the Community Site or any legal consequences arising from such access or any unauthorized use of the materials on the Website.

The Operator may not be held liable for any defaming, offensive or unlawful conduct of any User or any content the User dislikes.

MyName Kft. is not responsible for any damage or loss arising from the relationship between the Users.

The Operator does not under any circumstances accept liability for any direct, indirect, accidental, special, consequential or punitive damages arising from any false publication, violation of the Community Site, prostitution, paedophilia, child pornography, rape, abuse of women or children or any trafficking with them.

The Operator is not be liable under any circumstances for any damages, including, but not limited to, direct, indirect, incidental, special, consequential or punitive damages of any kind arising out of use or the lack of the service.

The Operator is not responsible for the publication of any inappropriate, illegal or prohibited contents on the Website, regardless of whether caused by a user, a programmer or an IT tool.

The Operator is not responsible for any error, omission, interruption, deletion or incompleteness in the operation of the service, nor for any delay of transmission, line failure,

theft, impairment, unauthorized use or communications between the users. The Operator is not responsible for any technical problems or injuries to the user's computer arising due to any defect or failure of any computer network, line failure, computer configuration or equipment, software, programme, service provider, server, website or e-mail, which is associated with the use of its Website or Services or downloading.

Myname Kft. does not assume any liability for any notices or offers originating other than from it, which appear on the Website it operates. The Operator does not guarantee or promise any result in connection with the use of the Community Site.

The Operator is not responsible for the quality, safety or legal compliance of the contents uploaded to the Community Site, and does not assume any liability for monitoring these products. The Operator is not responsible, either, for the veracity of the contents placed by the Users on the Community Site.

The Operator is not responsible for and will not interfere with legal disputes or transactions between Users. In the event that any dispute arises, the Users holds the Operator harmless from any claim, demand or damages.

The Operator is entitled but is not obliged to monitor the contents published and made available by the User on the Website. It is also entitled but not obliged to search signs of illegal activity through the information provided.

The User shall be exclusively liable for any contents disclosed or made available by the User, including for any material or non-material damage caused by such contents or otherwise incurred in relation thereto. No illegal content may be placed on the Website.

In the event that any third party, authority or court brings a claim or opens proceedings in relation to any content published or made available by the User, the User agrees to refund all the costs, expenses and damages incurred in relation to such claims or proceedings and also agrees to take all measures in connection with the violations and abuses (e.g. making a public or other declaration assuming liability for the abuse or the breach and clearly stating the integrity of the Operator) in order to protect the reputation of Myname Kft. and the Community Site operated by it.

Myname Kft. will cooperate with the authorities within the framework of the relevant laws in force from time to time to call to account the persons who committed the violation.

The Operator is entitled to exclude from using the Website and cancel any Uploading User who has not logged in the Community Site for over 6 months.

The User's accounts will be immediately and permanently suspended and deleted in case of a breach of this Contract. The consequences of the application of cancellation as a sanction are the same as those described in the paragraph concerning non-permitted content.

Termination

The Operator will delete the User's account and stop access to the Website if the User so requests, or if the content thereof is illegal, or if the User is in breach of the clauses of the Contract or if so ordered by the court or other authority. Cancelling the User's account will result in the termination of the contractual relationship established with the Operator, except for the clauses that survive the termination of the Contract, e.g.: data protection, copyright.

Users can initiate deleting their account in the “My data” menu item in their personal menu. In case a user deleted his/her account, Myname Kft. is entitled to retain the data required by the law, in particular data processing related to billing (8 years), which is required by Section 169(2) of Act C of 2000 on accounting.

The Operator reserves the right to stop the User’s access to the Website or the services thereof for any reason and free of charge. In this unexpected case, the Operator will give notice on stopping the user’s membership to the user’s email address. If the user is in breach of this Contract or any legislation, the Operator will be entitled to immediately terminate the user account and access to the website without notice.
